



MUNICIPAL ORDINANCE NO. 2023-05

“REPEALING PARAGRAPH 22 OF SECTION 2 OF MUNICIPAL ORDINANCE NO. 2019-15 ALSO KNOWN AS “KAUTUSAN SA PANGANGALAGA NG MGA YAMANG PANGKALINGANAN NG BUSTOS.”

WHEREAS, the Sangguniang Bayan, as the legislative body of the local government unit has the power to enact, amend or repeal ordinances and resolutions as stipulated in the Local Government Code of 1991;

WHEREAS, paragraph 22 of section 2 of the Municipal Ordinance (MO) 2019-15 (November 19, 2019), otherwise known as “KAUTUSAN SA PANGANGALAGA NG MGA YAMANG PANGKALINGANAN NG BUSTOS” designated the Bustos Tennis Court as one of the historical and cultural heritage of Bustos, Bulacan on the basis that it was built in 1970;

WHEREAS, after diligent research and public consultations there exists no national law or provincial ordinance declaring and/or designation the Bustos Tennis Court as a cultural heritage resource;

WHEREAS, the Sangguniang Bayan - Committee on Arts, Culture and Tourism held two public hearings on March 10, 2023 at the Tanggapan ng Sangguniang Bayan, Bakuran ng Bahay ng Pamahalaang Bayan ng Bustos and the Buisan Covered Court;

WHEREAS, the survey conducted during the above-mentioned public hearings showed that 100% of the attendees of the public hearings voted in favor of repealing Paragraph 22 of section 2 of MO 2019-15, and favored the establishment of facilities for senior citizens in lieu of the Bustos Tennis Court;

WHEREAS, resource speakers from the Office of the Mayor, Bustos Tourism Office, Bustos Library Office and civil society groups indicated that repealing paragraph 22 of section 2 of MO 2019-15 is in order for failing to meet the criteria for designating heritage and cultural resources provided under Section 6 of MO 2019-15;

TANGGAPAN NG SANGGUNIANG BAYAN

WHEREAS, the Office of the Mayor, Tourism Office, Bustos Library and constituents who have lived longer and prior the establishment of the Bustos Tennis court in 1970 attest that:

1. The Bustos Tennis Court does not possess historical, architectural, archaeological, or cultural significance in the Municipality of Bustos, the Province of Bulacan, and our country;
2. The Bustos Tennis Court has never been associated with the lives of persons significant in the Municipality's past;
3. The Bustos Tennis Court does not embody distinctive characteristics of a type, period, or method of construction;
4. The Bustos Tennis Court does not represent the work of a master designer, builder, or craftsman;
5. The Bustos Tennis Court is not a unique location or singular physical characteristic or is a view or vista representing an established and familiar visual feature of a neighborhood, community, or the municipality;
6. The Bustos Tennis Court is not a location of significant historic events.

WHEREAS, during the public hearing it was mentioned that the Tennis Court mostly served the interest of tennis enthusiasts from outside Bustos;


WHEREAS, after conducting two public hearings regarding the repeal of Paragraph 22 of Section 2 of municipal ordinance 2019-15, the attendees from various government offices, non-government organizations, barangay officials and volunteer groups, and civil society sectors unanimously voted in favor of the said repeal for the greater good of converting the Bustos Tennis Court to a Senior Citizen's Park;

WHEREAS, there is a need to repeal Paragraph 22 of Section 2 of Municipal Ordinance 2019-15 for the betterment and general welfare of the beloved senior citizens living within the municipality of Bustos.

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF BUSTOS, BULACAN, IN REGULAR SESSION ASSEMBLED:

Section 1. Paragraph 22 of Section 2 of Municipal Ordinance 2019-15 entitled "Kautusan sa Pangangalaga ng mga Yamang Pangkalinangan ng Bustos" is hereby repealed as follows:

Section 2. Separability Clause. – If any provision or section of this Act is held to be unconstitutional or invalid, the other provisions or sections hereof, which are not affected thereby shall continue to be in full force and effect.

Section 3. Repealing Clause. – All provisions of existing municipal ordinances of the Municipality of Bustos, orders, rules and regulations, or parts thereof which are in conflict or inconsistent with the provisions of this Act are hereby repealed, amended, or modified accordingly: *Provided*, That all provisions of Municipal Ordinance 2019-15 which are not inconsistent with this Act are hereby adopted.

Section 4. Effectivity clause – This Ordinance shall take effect following its publication in a newspaper of general circulation, within the Municipality of Bustos and upon posting at prominent places in the Municipal Hall for a period of three (3) consecutive weeks.


