WHEREAS, the Local Government Code of the Philippines (RA 7160) empowers the Sangguniang Bayan as a legislative body to enact ordinances, approve resolutions for an efficient and effective municipal government and in this connection shall determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from municipal funds and provide for expenditures necessary for the proper conduct of programs, projects, services, and activities of the municipal government;

WHEREAS, the Sangguniang Bayan, as the legislative body of the local government unit has the power to enact, amend or repeal ordinances and resolutions as stipulated in the Local Government Code of 1991;

WHEREAS, after diligent research and consultations with the Sangguniang Panlalawigan, Department of Budget and Management and Civil Service Commission Regional Office III, created positions shall be classified in accordance with Local Budget Circular No. 53, dated September 1, 1993;

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF BUSTOS, BULACAN, IN SPECIAL SESSION ASSEMBLED:

Section 1. Ordinance No. 2022-21 entitled "An Ordinance creating three (3) offices and seventeen (17) various positions in different offices of the Local Government Unit of Bustos, Bulacan" is hereby amended as follows:

Nutrition Officer IV Salary Grade 22 Plantilla No. 1011-32 shall now read as Nutrition Officer III Salary Grade 18 Plantilla No. 1011-45.


Section 2. Repealing Clause. – All provisions of existing municipal ordinances of the Municipality of Bustos, orders, rules and regulations, or parts thereof which are in conflict or inconsistent with the provisions of this Act are hereby repealed, amended, or modified accordingly: Provided, That all provisions of Municipal Ordinance 2022-21 which are not inconsistent with this Act are hereby adopted.

Section 5. Effectivity. – This Ordinance shall take effect immediately after approval.




