“TRANSFERRING ONE MILLION, SIX HUNDRED TWENTY FIVE THOUSAND PESOS (₱1,625,000.00) FROM THE 5% GENDER AND DEVELOPMENT (GAD) FUND UNDER THE MUNICIPAL SOCIAL WELFARE AND DEVELOPMENT OFFICE (MSWDO) PROGRAM FOR EARLY CHILDHOOD CARE AND DEVELOPMENT (ECCD) CENTER TO THE MAYOR'S OFFICE, PUBLIC EMPLOYMENT SERVICE OFFICE (PESO), BUSTOS COMMUNITY HOSPITAL, AND MUNICIPAL NUTRITION ACTION OFFICE.”

WHEREAS, the transferring of ₱1,625,000.00 from the Gender and Development Fund will enhance the capacities of these offices to deliver improved services and respond to urgent needs, thus promoting comprehensive and gender-sensitive development in the municipality;

“Section 336. Use of Appropriated Funds and Savings. Funds shall be available exclusively for the specific purpose for which they have been appropriated. No ordinance shall be passed authorizing any transfer of appropriations from one item to another. However, the local chief executive may, by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations.”


Section 4. Effectivity clause. — This Ordinance shall take effect immediately after approval.
