WHEREAS, the Local Government Code of 1991 mandates municipalities to promote the general welfare of the people and allocate funds to programs enhancing public service, with a focus on marginalized sectors;

WHEREAS, the need for enhanced skills and capacity-building among municipal staff has been identified as a critical priority to improve service delivery, which requires dedicated funding for comprehensive training programs;

WHEREAS, Section 336 of the Local Government Code of 1991, provides;

“Section 336. Use of Appropriated Funds and Savings. Funds shall be available exclusively for the specific purpose for which they have been appropriated. No ordinance shall be passed authorizing any transfer of appropriations from one item to another. However, the local chief executive may, by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations.”






Section 4. Effectivity clause. — This Ordinance shall take effect immediately after approval.


