“TRANSFERRING FIVE HUNDRED FORTY THOUSAND PESOS (P540,000.00) FROM THE MAINTENANCE AND OTHER OPERATING EXPENDITURES (MOOE) OF THE SANGGUNIANG BAYAN OFFICE TO BE USED FOR THE TRAINING EXPENSES AND FUEL, OIL, AND OTHER LUBRICANT EXPENSES.”

WHEREAS, the Local Government Code of 1991 mandates municipalities to promote the general welfare of the people and allocate funds to programs enhancing public service, with a focus on marginalized sectors;

WHEREAS, the Sangguniang Bayan Office has identified a need to strengthen its operational capabilities through targeted training and adequate provisions for fuel, oil, and lubricants to support the mobility and logistical requirements of its staff;

WHEREAS, Section 336 of the Local Government Code of 1991, provides;

“Section 336. Use of Appropriated Funds and Savings. Funds shall be available exclusively for the specific purpose for which they have been appropriated. No ordinance shall be passed authorizing any transfer of appropriations from one item to another. However, the local chief executive may, by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations.”

Section 1. Transferring of Funds. The Maintenance and Other Operating Expenditures of the Sangguniang Bayan Office is here by transferred as follows —




Section 4. Effectivity clause. — This Ordinance shall take effect immediately after approval.


