


**WHEREAS**, the Local Government Code of the Philippines (RA 7160) empowers the Sangguniang Bayan as a legislative body to enact ordinances, approve resolutions for an efficient and effective municipal government and in this connection shall determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from municipal funds and provide for expenditures necessary for the proper conduct of programs, projects, services, and activities of the municipal government;

**WHEREAS**, in response to the request of the Office of the Human Resource Management Office, and after a through inquiry and analysis, the Sangguniang Bayan deemed it necessary to create the position of Chief of Hospital SG-24 under the Bustos Community Hospital appropriating funds therefore and for other purposes;

**WHEREAS**, considering the funds to be utilized shall be source in FY 2025 appropriation for personnel benefits; hence; herein creation shall not affect the 45% Personal Services limitations;

**WHEREAS**, creating a Chief of Hospital position serves several critical purposes in managing and delivering high-quality healthcare services.

**TANGGAPAN NG SANGGUNIANG BAYAN**  
BAKURAN NG BAHAY PAMAHALAANG BAYAN NG BUSTOS, BULACAN

NOW THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN, IN A SESSION DULY ASSEMBLED, THAT:

**Section 1. Creation of Position.** – There shall be created the position of Chief of Hospital SG-24 under the Bustos Community Hospital in the Municipality of Bustos, Bulacan.

**Section 2. Qualifications.** – No person shall be appointed as Chief of Hospital I under the Bustos Community Hospital unless he/she have the following qualification standards:

- **Education:** Doctor of Medicine
- **Experience:** 4 years in position/s involving management and supervision
- **Training:** 40 hours of training and management
- **Eligibility:** RA 1080, as amended, (Physician)

**Section 3. Duties and Function.** –

- Oversees all managerial and administrative processes of the hospital;
- Formulates policies, plans, programs, and strategies to ensure implementation of health and high standard;
- Supervises daily activities of functional units;
- Ensures quality healthcare is provided for patients;
- Ensures high standards in clinical training for medical and allied medical personnel;
- Direct the administrative and technical activities of hospital;
- Recommends appointments, promotion and dismissal of staff;
- Supervises formulation of budget proposals;
- Directs and develops possible special programs within the hospitals as needed by the community.

**Section 4. Source of fund.** – For FY 2025, funds are allocated corresponding to the salary grade of the newly created positions in the AIP and Annual Budget for 2025.

**Section 5. Effectivity.** – This Ordinance shall take effect immediately after approval.
