WHEREAS, the Local Government Code of 1991 mandates municipalities to promote the general welfare of the people and allocate funds to programs enhancing public service, with a focus on marginalized sectors;

WHEREAS, there is an urgent need to augment the budget for Maintenance and Other Operating Expenses (MOOE) under the MSWDO to address the increasing demand for Aid in Crisis Situations (AICS);

WHEREAS, Section 336 of the Local Government Code of 1991, provides;

“Section 336. Use of Appropriated Funds and Savings. Funds shall be available exclusively for the specific purpose for which they have been appropriated. No ordinance shall be passed authorizing any transfer of appropriations from one item to another. However, the local chief executive may, by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations.”

Section 1. Transferring of Funds. The Municipal Social Welfare and Development Office (MSWDO) - Burial Assistance is here by transferred as follows —


