WHEREAS, as stipulated in Section 17, Article 2 of the 1987 Philippine Constitution “The State shall give priority to education, science and technology, arts, culture, and sports to foster patriotism and nationalism, accelerate social progress, and promote total human liberation and development.”;

WHEREAS, Section 3(2), Article 14 of the 1987 Philippine Constitution states that educational institutions “shall inculcate patriotism and nationalism, foster love of humanity, respect for human

rights, appreciation of the role of national heroes in the historical development of the country, teach the rights and duties of citizenship, strengthen ethical and spiritual values, develop moral character and personal discipline, encourage critical and creative thinking, broaden scientific and technological knowledge, and promote vocational efficiency.”;

WHEREAS, there is a need to come up with a simple but comprehensive history book or publication that shall be crafted by the Bustos Historical Panel;

WHEREAS, when the Bustos history book is crafted, it shall be made available at the Aklatang Bayan ng Bustos or any other online platforms handled by the Local Government Unit of Bustos.

NOW THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN, IN A SESSION DULY ASSEMBLED, THAT:

Section 1. Short Title - This Ordinance shall be known as the “Bustos Historical Panel Ordinance”.

Section 2. Declaration of Policy - It is hereby declared the policy of the Local Government of Bustos to take the lead in ensuring that local history is safeguarded, shared and taught to Bustosenyos.

Section 3. Purposes - It is the principal purpose of this Ordinance:

1. To establish the Bustos Historical Panel.
2. To create a simple yet comprehensive history book or manual that will be easily understood by locals and readers alike.

Section 4. Establishment of the Bustos Historical Panel - A Bustos Historical Panel is hereby created to craft an easy-to-understand history book or publication about Bustos, Bulacan.

Section 5. Composition of the Bustos Historical Panel - The Bustos Historical Panel shall constitute of the following:

1. Municipal Mayor – Chairman
 2. Municipal Vice Mayor - Vice Chairman

 4. Sangguniang Bayan Member Chairperson on Arts, Culture and Tourism
 5. Sangguniang Kabataan Federation President
 6. Association of Barangay Captains President

 9. Private Schools of Bustos Administrators Association Head
 10. Private School Teacher of History
 11. Municipal Tourism Officer


Section 14. Effectivity clause - This Ordinance shall take effect seven (7) days after its approval.

APPROVED and ADOPTED, the 3rd of November, 2022 by the Sangguniang Bayan at the Amado Raymundo Session Hall.


