WHEREAS, the Bustos Public Market and Bustos Slaughterhouse are essential public services that play a critical role in the economic and social well-being of the Municipality of Bustos and its constituents;

WHEREAS, the Municipality of Bustos currently classifies both the Bustos Public Market and the Bustos Slaughterhouse under the Local Economic Enterprise (LEE), requiring them to generate sufficient revenues to cover their operating costs and contribute to the municipality's income;

WHEREAS, despite their importance, these enterprises have faced challenges in generating adequate revenues to sustain their operations without compromising the quality and accessibility of services provided to the public;

WHEREAS, the inclusion of these facilities under the General Fund would ensure that both the Bustos Public Market and Bustos Slaughterhouse receive necessary financial support from the municipality, regardless of revenue generation, to ensure their continued operation and improvement;

WHEREAS, transferring the classification of these public facilities to the General Fund is in the best interest of the general public as it would allow for more efficient and equitable allocation of resources, while ensuring the availability of quality services.
