WHEREAS, Section 11, Article XIII of the 1987 Constitution declared that “the state shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health, and other social services available to all people at an affordable cost. There shall be a priority for the needs of the underprivileged, sick, elderly, disabled, women and children. The state shall endeavor to provide free medical care to paupers”;

WHEREAS, Section 17(a) of Republic Act 7160, otherwise known as the Local Government Code (LGC) of 1991, provides that “Local government units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them. They shall also discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this Code. Local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate or incidental to efficient and effective provisions of the basic services and facilities enumerated herein”;

WHEREAS, Section 33 of the LGC further provides that the “Local government units may, through appropriate ordinances, group themselves, consolidate, or coordinate their efforts, services, and resources for purposes commonly beneficial to them. In support of such under takings, the local government units involved may, upon approval of the sanggunian concerned after a public hearing conducted for the

purpose, contribute funds, real estate, equipment, and other kinds of property and appoint or assign personnel under such terms and conditions as may be agreed upon by participating local units through Memoranda of Agreement”;

WHEREAS, Section 19, Chapter V of the Republic Act No. 11223, otherwise known as the Universal Health Care (UHC) Act, state that “The DOH, Department of Interior and Local Government (DILG), PhilHealth, and LGUs shall endeavor to integrate health systems into province-wide health systems”;

WHEREAS, Section 20, Chapter V of the UHC Act further emphasizes that “The province-wide health system shall pool and manage, through a special health fund, all resources intended for health services to finance population-based and individual-based health services, health system operating costs, capital investments, and remuneration of additional health workers and incentives for all health workers”;


WHEREAS, Section 22(c) of the Local Government Code of 1991 stipulates that any agreement to be represented by the Municipal Mayor on behalf on the Municipal Government must be approved by the Sangguniang Bayan before it can be authorized.


THEREFORE, upon endorsement by **HONORABLE JULIET DJ. DELA CRUZ**, and unanimously agreed upon by all the members present.


