

“AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. FRANCIS ALBERT G. JUAN, TO REPRESENT AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE MUNICIPALITY OF BUSTOS AND THE DEPARTMENT OF HEALTH – CENTRAL LUZON CENTER FOR HEALTH AND DEVELOPMENT (DOH-CLCHD) FOR THE IMPLEMENTATION OF THE CONSTRUCTION, REPAIR, AND RENOVATION OF BUSTOS COMMUNITY HOSPITAL DUE TO THE DAMAGES BROUGHT BY TYPHOON CARINA.”

WHEREAS, Typhoon Carina, which formed east of the Philippines on July 19, 2024, unleashed torrential rains and powerful winds, leading to widespread flooding across the country, including the municipality of Bustos;

WHEREAS, the storm caused rivers to overflow and generated massive waves along coastal areas, resulting in significant loss of life, injuries, and extensive damage to health facilities and infrastructure;

WHEREAS, the damage to health facilities and infrastructure is extensive, with recovery efforts expected to take considerable time and resources;

WHEREAS, the Bustos Community Hospital was particularly hard-hit, with floodwaters inundating the facility and disrupting medical services.


THEREFORE, endorsed by **HONORABLE SOLIMAN C. SANTOS**, and unanimously agreed upon by all the members present.
