WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that local government units (LGUs) shall exercise the powers necessary to promote the general welfare of its constituents, particularly in the promotion of health and safety;

WHEREAS, the local government of Bustos has acquired Patient Transport Vehicles (PTVs) to be donated to the fourteen (14) barangays within its jurisdiction, aimed at enhancing health services and ensuring faster response to medical emergencies in the barangays;






THEREFORE, endorsed by **HONORABLE JULIET DJ. DELA CRUZ**, and unanimously agreed upon by all the members present.


