WHEREAS, the Department of Social Welfare and Development (DSWD) is mandated to provide comprehensive social protection programs and services to the marginalized and disadvantaged sectors of society;

WHEREAS, the Technical Assistance and Resource Augmentation (TARA) Program of the DSWD aims to support local government units (LGUs) in the effective implementation of social welfare programs through the provision of technical assistance and resources, particularly during emergencies, disasters, and other crises;

WHEREAS, the local government of Bustos recognizes the importance of strengthening its capacity to respond to the needs of its constituents, especially in times of emergencies, and acknowledges the need for collaboration with national government agencies to ensure the effective delivery of social services;

WHEREAS, the DSWD, through the TARA Program, offers critical support to LGUs by providing technical assistance, capacity-building initiatives, and resource augmentation to enhance the LGU's capacity to implement social welfare programs and services;

WHEREAS, the partnership between the LGU and the DSWD under a Memorandum of Agreement (MOA) will facilitate a more coordinated and responsive approach in addressing the needs of the vulnerable sectors of

society, particularly in the areas of disaster response, social protection, and poverty alleviation;




THEREFORE, upon motion by **HONORABLE PHILLIP WRYNER B. SANTOS**, and unanimously agreed upon by all the members present.


