“AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HONORABLE FRANCIS ALBERT G. JUAN, TO REPRESENT AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE MUNICIPALITY OF BUSTOS AND THE BUREAU OF FIRE PROTECTION (BFP) RELATIVE TO THE NAMING AND DESIGNATION OF MUNICIPALITY AS COLLECTING AGENT FOR THE FIRE SAFETY INSPECTIONS FEES (FSIF).”

WHEREAS, the Bureau of Fire Protection (BFP) is mandated to ensure public safety through the enforcement of fire safety regulations, including conducting Fire Safety Inspections and collecting Fire Safety Inspection Fees (FSIF) from establishments within its jurisdiction;

WHEREAS, Section 17 of the Local Government Code of 1991 (Republic Act No. 7160) empowers local government units (LGUs) to provide efficient and effective delivery of basic services and facilities, including those related to fire prevention and public safety;

WHEREAS, Section 12(h) of Republic Act No. 9485 (Anti-Red Tape Act of 2007), as amended by Section 11 of Republic Act No. 11032 (Ease of Doing Business and Efficient Government Service Delivery Act of 2018) has vested the BFP the discretion to enter into agreements with cities or municipalities to allow the latter to assess and collect fire safety inspection fees;

WHEREAS, the Municipality of Bustos recognizes the importance of streamlining the collection process of FSIF to enhance accessibility for its constituents, improve revenue generation, and strengthen compliance with fire safety standards within the municipality;



THEREFORE, upon motion by HONORABLE ALJHANEAL E. QUIÑONES, and unanimously agreed upon by all the members present.


