“AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HONORABLE FRANCIS ALBERT G. JUAN, TO UTILIZE THE PHILHEALTH CAPITATION TRUST FUND, PARTICULARLY FOR THE PHILHEALTH KONSULTA PACKAGE.”

WHEREAS, Article II, Section 25 of the 1987 Philippine Constitution declares it as a state policy to ensure the autonomy of local government units (LGUs) to enable them to become self-reliant and capable partners in the pursuit of national development;

WHEREAS, Section 17 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates LGUs to exercise their powers to deliver basic services and facilities, including health services, and provides the authority to allocate and utilize resources for these functions;

WHEREAS, under Section 7 of Republic Act No. 11223, or the Universal Health Care Act, it is established that all Filipinos are automatically enrolled into the National Health Insurance Program (NHIP), with the government ensuring that funding and necessary support are provided to guarantee adequate healthcare access for all, particularly the indigent and vulnerable sectors;

WHEREAS, Section 15, Article II of the 1987 Philippine Constitution emphasizes the State's commitment to protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, the Philippine Health Insurance Corporation (PhilHealth), through its initiatives like the PhilHealth Konsulta Package, has made available capitation funds sourced from the outpatient consultation and diagnostic benefit package to accredited LGUs, including

the Municipal Government of Bustos, Bulacan, to enhance healthcare service delivery at the local level;

WHEREAS, the PhilHealth Konsulta Package is an integral part of the government's health insurance program aimed at providing comprehensive outpatient care services to beneficiaries, which includes preventive, diagnostic, and consultation services to promote overall well-being and prevent hospitalizations;

WHEREAS, the utilization of the PhilHealth Capitation Trust Fund by the Municipal Government of Bustos, Bulacan, will ensure that these health services are made accessible and effective, thereby improving health outcomes and aligning with the goals of the national government to provide universal health coverage;

THEREFORE, upon motion by **HONORABLE ALJHANEAL E. QUIÑONES**, and unanimously agreed upon by all the members present.

RESOLVED, as it is hereby **RESOLVED**, that the Local Chief Executive, Honorable Francis Albert G. Juan, is hereby authorized to utilize the PhilHealth Capitation Trust Fund, particularly for the implementation and operational support of the PhilHealth Konsulta Package.


RESOLVED FURTHER, that the following guidelines be followed for the allocation of PhilHealth reimbursements to wit:

- a. Sixty Percent (60%) for the Operational Costs which shall cover the drugs and medicines, reagents, medical supplies, laboratory supplies, equipment and office supplies; and
- b. Forty percent (40%) shall be exclusively utilized as honoraria of the staff of Bustos Community Hospital and in the improvement of their capabilities to provide better health services, broken down as follows:
 - i. Fifty percent (50%) for the Physician/s; and
 - ii. Fifty percent (50%) other health professionals and non-health professional and hospital staff.


