JUAN, TO REPRESENT THE MUNICIPALITY OF BUSTOS, BULACAN, IN APPLYING FOR A THREE-PHASE TRANSFORMER AND ELECTRIC METER WITH THE MANILA ELECTRIC COMPANY (MERALCO) TO BE UTILIZED IN THE DR. PABLITO MENDOZA GYMNASIUM AND TO SIGN NECESSARY DOCUMENTS THEREOF.”**

**WHEREAS**, the Municipality of Bustos recognizes the vital role of public infrastructure, such as the Dr. Pablito Mendoza Gymnasium, in serving the needs of its residents for sports, recreational, cultural, and other community activities;

**WHEREAS**, the efficient and uninterrupted operation of the Dr. Pablito Mendoza Gymnasium necessitates the installation of a three-phase transformer to ensure adequate and reliable electrical supply, particularly for high-demand events and activities;

**WHEREAS**, the Manila Electric Company (MERALCO) is the authorized utility provider capable of supplying and installing the necessary three-phase transformer to support the electrical requirements of the facility;

**WHEREAS**, the application process for the said transformer requires a duly authorized representative of the Municipality of Bustos to act on its behalf in all necessary transactions with MERALCO.

**THEREFORE**, upon motion by **HONORABLE LEO T. SANTOS**, and unanimously agreed upon by all the members present.


