“ADOPTING THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG), ANTI-RED TAPE AUTHORITY (ARTA), AND DEPARTMENT OF FINANCE (DOF) JOINT MEMORANDUM CIRCULAR NO. 2021-01, ENTITLED ‘OMNIBUS GUIDELINES ON THE SUSPENSION OF LGU IMPOSITION AND COLLECTION OF ILLEGAL FEES AND TAXES RELATIVE TO THE TRANSPORT OF GOODS AND PRODUCTS.’”

WHEREAS, the DILG, Anti-Red Tape Authority (ARTA) and the Dept of Finance (DOF) as relevant government agencies have issued Joint Memorandum Circular No. 2021 on April 28, 2021, establishing omnibus guidelines on the suspension of the Local Government Unit (LGU) imposition and collection of illegal fees and taxes related to the transport of goods and products;

WHEREAS, the Joint Memorandum Circular aims to streamline processes, promote ease of doing business, and remove regulatory burdens that hinder the free flow of goods and products across the country;

WHEREAS, the suspension of illegal fees and taxes by LGUs is vital in enhancing economic activities, especially during the ongoing recovery period from the COVID-19 pandemic, and in ensuring a seamless and unhampered movement of goods and products which is crucial for economic stability and growth;

WHEREAS, the adoption of the said guidelines by the municipality will demonstrate its commitment to the principles of good governance, transparency, and accountability in the delivery of public service.
