WHEREAS, Republic Act No. 9344 (Juvenile Justice and Welfare Act) and Republic Act No. 7610 (Special Protection of Children Against Abuse, Exploitation, and Discrimination Act) mandate the establishment of Local Councils for the Protection of Children (LCPC) to ensure the promotion and protection of children’s rights at the local level;

WHEREAS, the Department of the Interior and Local Government (DILG) Memorandum Circular No. 2021-001 emphasize the obligation of local government units (LGUs) to institutionalize functional LCPCs and allocate resources for their programs;

WHEREAS, the LCPC of Bustos, in compliance with national mandates and local policies, has formulated its Annual Work and Financial Plan (AWFP) for Fiscal Year 2024, outlining programs, activities, and budgetary requirements to address the needs of children in the municipality;

WHEREAS, the Sangguniang Bayan of Bustos recognizes the urgency of adopting the AWFP to secure funding, mobilize stakeholders, and meet DILG’s criteria for the Child-Friendly Local Governance Audit (CFLGA).


